Terms and Conditions

GENERAL ELIGIBILITY

This program offers financial incentives for the installation of equipment that reduces natural gas use for water heating. Applications will be processed on a first-come, first-served basis. To qualify for rebates, an applicant must meet the following eligibility requirements:

- ▶ Applicant must be a current Minnesota Energy Resources residential customer living in Minnesota.
- ▶ Customer information must be completely filled out on front of application.
- ▶ To avoid delay, a final, itemized receipt for all material and labor related to the equipment and installation must be attached to this rebate application. All applications must be received within 60 days of installation.
- ▶ Rebate checks will be made payable to customer or property owner shown on receipt. This must match the customer or property owner of record. Dealers or contractors are not eligible to receive their customer's rebate.
- ▶ This program is subject to regulatory rules and orders. Minnesota Energy Resources reserves the right to change any portion of this program or to end this program without notice.
- ▶ Where applicable, energy efficiency ratings must comply with those listed by the Air-Conditioning, Heating and Refrigeration Institute (AHRI).
- ▶ The customer certifies that the water heater in the residence is fueled by natural gas.
- ▶ For Drain Water Heat Recovery, homemade systems are not eligible.
