

Applying for your rebate is easy!

Review the checklist below, complete, print, sign the application, and submit.

Checklist for completing your application

- Read** the terms and conditions to determine if you are eligible for a rebate.
- Verify** the equipment you install meets the specifications and equipment or service guidelines. All products require proof of purchase and may require additional documentation depending on the equipment installed. See proof of purchase requirements.
- Purchase and install** qualifying equipment or service. The rebate application must be received within 60 days of installation. Work with your contractor to complete and submit the application.
- Complete** steps 1-6 of the application.
- Print, sign and date** the application.
- Mail** your completed application and documentation.
- Keep** a copy for your records.

Here's what you'll need to get started:

- Must be an active Minnesota Energy Resources natural gas customer
- Minnesota Energy Resources account number
- Customer and contractor contact information
- Proof of purchase
- Additional equipment or service documentation (if required)

Proof of purchase requirements:

Retailer/contractor dated receipt or invoice must be attached and reflect the product(s) and or service(s) listed on the application and must include:

- Retailer/contractor name, address and phone number
- Customer name
- Installation address
- Product(s) or service(s) details including:
 - Quantity
 - Manufacturer
 - Model number
 - Purchase price for each product or service
 - Installation costs (*if applicable*)
 - Installation or service date (*if installed by contractor*)

We cannot process your application without proof of purchase that contains all information specified above.

Your rebate check will be mailed approximately four to six weeks after we receive a completed, eligible application including all required documentation.



1. Eligibility

Applicant must be a current non-residential Minnesota Energy Resources customer or property owner for the installation address associated with the account number provided. Furthermore, the equipment and/or measures installed and rebated must be installed at the property associated with this account number and must reduce use of natural gas energy.

2. Rebate offer

Rebates are based on a combination of energy saved and project implementation costs and is the lesser of: project buydown to one year simple payback, \$10.00 per decatherm saved during the first year, or full incremental cost. Minnesota Energy Resources reserves the right to adjust final rebate amounts based on the actual installed costs and natural gas savings.

3. Compliance

All projects must comply with applicable federal, state and local laws and regulations, including building codes. All equipment must be new; used or refurbished equipment is not eligible for rebates.

4. Application

Application forms must be filled out completely, and applications must include detailed equipment information, including make, model, and quantities before a rebate amount can be determined. Applications also must include project material, equipment and labor costs. Incomplete applications will either delay payments or result in denial of application approval.

5. Payment

Once a completed application is submitted and approved, payment is usually made within 60 calendar days. Minnesota Energy Resources reserves the right to refuse payment and participation if customer violates program terms and conditions. Contractors or dealers are not eligible to receive the customer's rebate.

6. Inspection

Minnesota Energy Resources reserves the right to conduct on-site pre-installation and post-installation inspections of proposed and installed projects.

7. Monitoring and verification (M&V)

Projects with estimated annual savings of 20,000 decatherms or more will be subject to M&V, as required by the Minnesota Department of Commerce. An M&V plan is required prior to project installation and is subject to approval by the Minnesota Department of Commerce. M&V may require additional data collection by the customer and may require additional equipment such as instrumentation and data loggers. Rebate payments will be split into two or more parts for all projects requiring M&V. Final payment will be made upon completion and approval of M&V activities as outlined in the approved M&V Plan and may be adjusted based on the M&V results.

8. Taxes

Rebates may be subject to federal and/or state income tax reporting. Applicant is responsible for contacting a qualified tax advisor to determine tax liability. Minnesota Energy Resources is not responsible for any tax liability imposed on customer due to rebate payment.

9. Publicity

Minnesota Energy Resources reserves the right to publicize customer's participation in this program unless customer specifically requests otherwise.

10. Program discretion

Rebates are available on a first-come, first-served basis. Rebate amounts and offerings are subject to change or termination without notice at the discretion of Minnesota Energy Resources. Minnesota Energy Resources reserves the right to withhold rebate payment until identified problems are resolved and to withhold or terminate a rebate payment due to customer's failure to follow terms and conditions.

11. Misrepresentation

Making false statements on any Minnesota Energy Resources application is punishable by law. Any person who knowingly files an application containing materially false information or who purposely conceals information commits a fraudulent act that subjects such person to criminal and civil penalties. Minnesota Energy Resources shall have the right to recover payments made in reliance on fraudulent or misrepresented information. This section shall not limit other remedies that may be available for the filing of false or fraudulent applications.

12. Intellectual property

Customer shall not use the Minnesota Energy Resources program name or logo in any marketing, advertising, or promotional material without written permission from Minnesota Energy Resources.

13. Disclaimer

Minnesota Energy Resources makes no representation or warranty, and assumes no liability with respect to the quality, safety, performance, or other aspect of any design, consulting, product, system, equipment, or appliance installed or received. Minnesota Energy Resources expressly disclaims any such representations, warranties, and liability, including but not limited to any implied warranties or merchantability for fitness for a particular purpose. Minnesota Energy Resources does not guarantee that installation and operation of incentivized measures will result in reduced energy usage or in cost savings. Minnesota Energy Resources is not responsible for the proper disposal or recycling of any waste generated. Minnesota Energy Resources is not liable for any damages, including incidental or consequential damages, arising out of the operation or malfunction of the products, equipment, or appliances, or the installation thereof.

14. Indemnification

Customer agrees, to the fullest extent permitted by law, to indemnify, hold harmless, and defend Minnesota Energy Resources, its officers, employees, and representatives from and against all losses, damages, expenses, fees, costs, and liability arising from any program, design, consulting, product, system, installation, equipment, or appliance. Customer agrees that such obligations under this section shall survive expiration or termination of this Agreement and shall not be limited to amounts covered by insurance. To the maximum extent permitted by law, Customer agrees to limit Minnesota Energy Resources' liability to the incentive estimates identified by Minnesota Energy Resources regardless of cause of action or legal theory asserted.

15. Release of customer information

Customer agrees to the release by Minnesota Energy Resources of any customer data, including personally identifiable information, to any contractor or vendor providing services or support under the program.

16. Miscellaneous**A. Governing law**

This application shall be governed, construed, and enforced in accordance with the laws of the state of Minnesota without regard to any conflict of law principles.

B. Assignment

Minnesota Energy Resources may assign this Agreement or any of Minnesota Energy Resources' rights, obligations, interests or responsibilities hereunder, in whole or part, without the consent of customer.

C. Severability

If any provision of this Agreement is deemed unenforceable, all remaining provisions will continue in full force and effect. Furthermore, this Agreement shall be reformed to include a provision as similar to the unenforceable provision as possible and still be enforceable.

D. Risk of loss

Minnesota Energy Resources at no time assumes risk of loss for any property of customer.

E. Waiver

No failure or delay by any party in exercising any right hereunder shall operate as a waiver, nor shall any single or partial exercise of a right preclude any further exercise of any other right.
